Summary

Dominic has very considerable experience in handling both domestic and international construction and engineering disputes of all sorts. He has been involved in a number of landmark cases including *London Borough of Merton v Stanley Hugh Leach*, *Malmaison v Henry Boot*, *Crest Homes v Marks* and *Edmund Nuttall v RG Carter and Discain v Opecprime*. He has been involved with disputes on major projects such as the Hong Kong Airport, the Channel Tunnel Rail Link, Wembley Stadium, the Docklands Light Railway and the Broadgate Development.

He has represented and advised parties in literally dozens of other adjudications in England and Northern Ireland involving construction and engineering disputes of all sorts, and has also acted for parties in numerous enforcement situations.

Dominic has acted for a number of developers and funders in advising on amendments to standard form construction contracts and in the drafting of bespoke consultancy appointments and warranty agreements, performance and payment guarantees and forms of bond in connection with office, shopping centre, warehouse and business park developments.

Dominic also has significant non-contentious experience, having been involved in drafting engineering and construction contracts and consultant appointments together with ancillary documentations such as bonds, guarantees and collateral warranties.
